### **Our Mission**



Concern for Animals was founded by Ann Albohn and Joyce Pearce with the goal of helping those who cannot help themselves. We focus on empowering people to responsibly care for the pets they rely on for love, aid, comfort, and protection. Our work improves the lives of both pets and people, reduces pet over-population, and helps suffering people overcome financial hurdles who may otherwise abandon their pets or surrender them to already overloaded animal shelters.

Concern for Animals is a charitable 501(c)(3) that provides aid for low-cost spay/neuter, medical care, and rescue and adoption in Thurston, Mason, Lewis, and Grays Harbor Counties.

Thanks to a generous donation from a long-time supporter, the CFA team was able to dedicate time at the beginning of the year to conduct a valuable mission and vision overhaul. Working with a Business and Executive Coach, the team refocused CFA's mission, vision, and values as well as crafted a strategic plan to see the organization through 2023 and beyond. CFA's core mission hasn't changed, but we updated the language to reinforce what we stand for and who we serve. It was a fantastic experience that has helped further boost our passion and will act as a guiding force as we continue to grow and evolve to best meet the ever changing needs of the communities within our service area.

We are still finalizing the mission, vision, and more - but what you may notice changing in the next little while is our tagline! While we will still be helping those that cannot help themselves in practice, our updated tagline will now be:

## 2023 Highlights

- CFA welcomed Amy Geier to the team as our new Outreach & Development Coordinator and reassessed longtime Operations & Programs Coordinator Gina Stommes' position, updating it to Operations & Programs Manager.
- Thanks to a generous donor we expanded into Grays Harbor County, adding an additional 76,000 people to our service area. The first phase of the expansion was a mobile food bank, made possible by a new van.
- To better serve the community the CFA team conducted a valuable mission and vision overhaul. This was made possible through a generous donation from a long-time supporter,
- We raised a record breaking amount this past year. A net \$7, 798 during the CFA Spring Plant & Gift Sale, and \$94,795 at Toast for Tails!
